March 1, 2019 (Tokyo, Japan) — AUTOBACS SEVEN Co., Ltd. ("the Company," Representative Director and Chief Executive Officer: Kiomi Kobayashi), announces the interim results of acquisition of its own shares, under Article 156 of the Japan's Corporation Law, as applied pursuant to Article 165, paragraph 3 of the same law.

1. Period of acquisition: From February 1, 2019 through February 28, 2019

2. Total number of shares acquired: 880,000 shares3. Total cost of acquisition: 1,645,868,800 yen
