# AUTOBACS SEVEN announces Merger and Changes of Trade Names for Consolidated Store Subsidiaries

(Translation of Major Points of Japanese Release)

February 28, 2020 (Tokyo, Japan) — AUTOBACS SEVEN Co., Ltd. (the "Company," Representative Director and CEO: Kiomi Kobayashi) announces the merger of Hiroshima AUTOBACS Ltd., a consolidated subsidiary of the Company, with four other consolidated subsidiaries (the "Merger") and changes in trade names of Hiroshima AUTOBACS Ltd, Yumesho Ltd., AUTOBACS Mino Ltd. and AUTOBACS SUN ACE. Ltd., As this is a merger of consolidated subsidiaries, certain details have been omitted from this disclosure. An outline of the Merger and changes of trade names is as described below.

#### 1. Reason for the Merger and changes in trade names of consolidated subsidiaries

Under the Five-year Rolling Plan 2019, the AUTOBACS Group is implementing various measures to increase profits in the domestic AUTOBACS business.

To respond to rapid changes in the automobile industry, it is essential to strengthen communication between headquarters and stores for thorough implementation of the Group measures, while for regional strategies, it is necessary to adopt individual strategies that are appropriate for on-site situation.

The Company has recently decided to adopt a divisionalized organization system that enables decision makings closer to the work site. With respect to subsidiaries primarily engaging in store operation, several subsidiaries will be integrated to streamline management, to ensure compliance with the direction and policies of the overall AUTOBACS chain. Moreover, in-house company systems will be introduced at subsidiaries, thereby facilitating a prompt response to the needs of local customers. In this manner, the Company strives to build an organization that focuses on the balance of overall optimization and individual optimization.

#### 2. Content of the Merger

Hiroshima AUTOBACS Ltd., a consolidated subsidiary of the Company, will merge with four other consolidated subsidiaries consisting of AUTOBACS Yamaguchi Ltd., AUTOBACS Nankai Ltd., AUTOBACS Kagawa Ltd. and AUTOBACS Ehime Ltd., subject to approval at the general shareholders' meeting of each company.

#### (i) Schedules

General shareholders' meeting to approve the Merger (each company concerned): March 26, 2020 Date of Merger (effective date): April 1, 2020

#### (ii) Merger method

The Merger will be an absorption-type merger with Hiroshima AUTOBACS Ltd. as the surviving company and AUTOBACS Yamaguchi Ltd., AUTOBACS Nankai Ltd., AUTOBACS Kagawa Ltd. and AUTOBACS Ehime Ltd. as companies to be merged.
