AUTOBACS SEVEN Announces Capital and Business Alliance

with a Philippine Company

January 13, 2016 (Tokyo, Japan) — AUTOBACS SEVEN Co., Ltd. ("the Company," Representative Director and CEO: Setsuo Wakuda) announced that it has reached an agreement and signed to related documents to enter into a capital and business alliance with Motech Group in Philippines.

1. Purpose of the capital and business tie-up

Since the economy of the Philippines is growing rapidly and the number of cars is rising, the Company considered there is a large potential in the retail and wholesale of automotive related goods and automotive repair services, and decided to enter into these business fields through an alliance with Motech Group that operates an automotive maintenance and repair service chain in Philippines. The Company will continue to invest its management resources and make concerted efforts to develop overseas market that contains great business opportunity.

In the ASEAN region, the AUTOBACS Group operates three stores in Singapore, six in Thailand, four in Malaysia and one in Indonesia since its first opening in Singapore in 1995.

2. Contents of the capital and business tie-up

The Company acquires 9.93% of the share of Magnificent'7 Automotive and Franchising Company ("Magnificent'7"), which operates an automotive maintenance and repair service chain in Philippines. Through this alliance, it is expected for the Company to share its business knowledge and skills required for multiple store development and to supply its merchandise to Magnificent'7.
