AUTOBACS SEVEN announces Change (Additional Appointment) of Representative Director and Candidates for the Board of Directors

(translation of major points of Japanese release)

March 28, 2022 (Tokyo, Japan) – Following the Board meeting held today, AUTOBACS SEVEN Co., Ltd. (Representative Director and Chief Executive Officer: Kiomi Kobayashi) announces the resolution of the changes below in representative directors effective April 1, 2022, and candidates for the Board of Directors to be proposed at the 75th Ordinary General Meeting of Shareholders to be held in late June, 2022.

2) Reason for the change

Towards the realization of the Company's Vision 2050 – Creating Our Future Together, Mr. Kiomi Kobayashi (Representative Director and Chief Executive Officer) continues to focus on expanding into new fields that the Company has never experienced before.

To ensure business results from these challenges within a drastically changing business environment, it is necessary to promote further transformation at a speed that surpasses changes in the business environment.

Considering this, the Board of Directors has selected Mr. Yugo Horii, who has worked closely with Mr. Kobayashi to realize the Company's Vision 2050 and has also supported the officers in each field to improve their effectiveness, as the new leader of the Company.

Once assuming the position of Representative Director and Chief Executive Officer, Mr. Horii will also assume the role of Chief AUTOBACS Chain Officer to lead the mid to long-term growth of the entire AUTOBACS Chain*.

- i. The Company will have a structure consisting of two representative directors; Mr. Kiomi Kobayashi and Mr. Yugo Horii.
- ii. The current representative director, Mr. Kiomi Kobayashi is to assume the post of Director and Chairman and Chairman of the Board with the approval of the 75th Ordinary General Meeting of Shareholders scheduled to be held in late June 2022 and the subsequent Board of Directors meeting. Upon this, the Company is submitting amendments to the Articles of Incorporation to the 75th Ordinary General Meeting of Shareholders.
- iii. This proposal has been resolved by the Board of Directors after being consulted by the Company's Corporate Governance Committee, which is an advisory body to the Board of Directors.
